



CALL FOR PAPERS AND POSTERS

This call is addressed to anyone registered for the First World Conference on Evidential Legal Reasoning that will take place on 6, 7 and 8 June 2018 in the city of Girona. Authors of accepted papers or posters will be issued a certificate of participation that will include the title of the work or poster presented.

There are two open calls. Anyone registered at the Conference can participate in one or both of them:

1. Call for posters

Although this type of presentation is not traditional in the social sciences, we want to test the importance and effectiveness of this methodology, commonly used in the hard sciences.

During coffee breaks and recesses, in the main hall of the auditorium, Conference attendees will find posters presenting the key ideas of various research studies, which the author(s) can explain and/or discuss in response to questions. The aim is to promote communication and debate among attendees about the research work presented in the posters.

The poster should contain a brief presentation of the most relevant ideas of a recently published or soon to be published article. Specifically, the poster should include:

- i. The title and, where appropriate, the subtitle of the work.
- ii. The main thesis that will serve as the unifying thread of the work.
- iii. The main arguments. If the work is linked to a specific legal system, a brief contextualization is suggested.
- iv. The conclusions of the work.
- v. The way in which this work is expected to impact evidentiary law and/or practices in the author's country and/or evidential reasoning.

Rules for submitting posters:

Posters can be presented in Spanish or English.

Only one poster per registered person will be admitted.

A total of 20 posters will be accepted.

Accepted posters will be printed by the Conference organizers in size A1 with vertical orientation.

Any graphic or text must be legible at a distance of 1.5 meters.

Anyone not yet registered for the Conference may submit a poster but it will only be considered for exhibition if the author registers by 15 April 2018.



Important dates:

Poster proposals can be submitted until 15 March 2018. Send a PDF file of the complete poster (one page only) by email to catedradeculturajuridica@udg.edu

The list of accepted posters will be published on 2 April 2018.

2. Call for papers

Papers must deal with evidential reasoning. All papers that meet the requirements for publication in a scientific journal will be chosen to create a specialized repository available on the Conference website.

Rules for submitting papers:

Papers can be presented in Spanish or English.

Only one paper per registered person will be admitted.

Submitting papers implies the author's acceptance of the work being posted on the Conference website (www.chairinlegalculture.com) without access restrictions until the end of the event.

Papers submitted this way will not be presented orally at the Conference.

Anyone not yet registered for the Conference may submit a paper but it will only be posted on the website if the author registers by 15 April 2018.

Accepted papers will be published within 20 days of submission, in the order in which they are received.
